## DECLARATION

I have applied for membership of The Target Sports Centre, and have read and understood the following declaration and agree to abide by this at all times.

1. I declare I am not a prohibited person under the 1968 Firearms Act and accept that the Rehabilitation of Offenders Act of 1974 does not apply.
2. I accept that my personal details will be supplied to West Dorset Police for checking prior to my acceptance as a full member of the Target Sports Centre.
3. I am not currently awaiting the outcome of any criminal proceeding, which may render me a prohibited person.
4. I have not had an application for a firearm or shotgun licence refused by the police or had a certificate revoked.
5. I will inform the club should my firearms certificate be revoked in the future.
6. I do not know of any reason why I would be refused a firearms certificate or a shotgun certificate.
7. I will inform the Target Sports Centre of any criminal proceeding, which may render me a prohibited person.
8. Should I in the future become a prohibited person I will inform the club.
9. The Target Sports Centre is under no obligation to accept me as a member, and they reserve the right to terminate my membership and do not have to give a reason for doing so – no fees will be refunded.
10. I will not be accepted as a full member until I have completed the probationary period.
11. I undertake to make not less than 6 shooting visits within my probationary period of three months.
12. I will conduct myself in a safe and responsible manner at all times and accept and abide by the club rules.
13. I accept that if I leave the club or have my membership terminated by the club I will not receive any form of compensation or return of membership fees.
14. We are required by law as a Home Office approved club to inform the licensing authorities of non-attendance for more than 12 months, by any members of the club who are firearms certificate holders.
